## Member of the Year Program

This program was designed to acknowledge UFSC-GKC members for their continued support and dedication to the chapter. All members in *\*Good Standing* are eligible and encouraged to participate in this program. The recipient of this award is the member who accumulates the most points for participation in UFSC-sponsored events during the fiscal year beginning on January 1<sup>st</sup> and ending on December 31<sup>st</sup> of each year.

### CRITERIA FOR UFSC-GKC MEMBER OF THE YEAR

All members of UFSC in *\*Good Standing* are eligible and encouraged to participate in accumulating points towards becoming the *UFSC-GKC Member of the Year*. One member will be honored at the annual Urban Financial Services Coalition-GKC Reception and Scholarship Awards Program for their level participation in and commitment to the organization. Points are awarded to members for their participation in the various UFSC-GKC - sponsored events.

1. All activities must occur during the UFSC Fiscal Year (January 1<sup>st</sup> through December 31<sup>st</sup>). The President requests that all point totals for each month be submitted to him/her no later than the first Friday of each subsequent month. Committee and/or Event Chairpersons are responsible for assigning point totals (in accordance with the *UFSC-GKC Member of the Year -- Point System*) for their event and submitting each participant's earned points to the President.
2. The member who has accumulated the highest number of points will determine the *UFSC-GKC Member of the Year*. A mid year report will be given at the December Membership Meeting. This will give members the opportunity to gain points where necessary. In the event of a tie, the President reserves the right to make multiple awards or to develop an elimination process.

- Attend 50% of the general membership meetings, applicable committee meetings, and UFSC Sponsored Events.
