- Individual headshot or photograph of student only with acceptable background
- Written essay following UFSC-GKC Essay Guidelines
- Official current student transcript
- Full time student schedule that verifies class enrollment (current or future)
- Completed Bronston Scholarship Application Form

Incomplete applications will not be accepted

Your submitted essay must meet the following requirements

- 1.5 up to 3-pages
- 12-inch Ariel Font only
- Double spaced format
- Submitted Essay must be one of the 5 topics listed below
- If applicable, references must be cited

2024 UFSC Essay Topics:

"Money, Wealth and Disparities: Agony to Action, Creating Inclusive Access"

As people of color continue to seek social and racial justice in the wake of the nation's most recent reckoning with the enduring vestiges of slavery, it is equally critical that we work to strengthen our communities financially, build wealth, and leave a legacy for generations yet unborn. How do we overcome the systemic and structural exclusion of Black people from economic opportunities in America?

"Critical Upgrade: African American Inclusion in the Financial Tech Sector!"

What is the current state of diversity in the financial tech sector of the financial services industry? How do we best address the inequities through public- private partnerships moving forward? What are the best practices / strategies that have been utilized in other sectors to achieve full representation of African Americans at every level of the financial tech sector of the financial services industry?

"Future of Work in a Post-COVID Economy"

As the global pandemic COVID-19 continues to surge in America, revolutionize our lives, and permanently change the nature of work, what are the trends, patterns, and skills that will affect African Americans' competitiveness in the new economy? How can the African American workforce better prepare itself to be competitive in a post-COVID economy?
